

GUNS AND DRUGS SEND SUBLETTE COUNTY RESIDENT'S TO PRISON

On December 19, 2008, the last of six (6) person(s) were sentenced in a long term Drug Conspiracy Investigation, which started in 2006, and spanned from Sublette County to the Salt Lake City, Utah, area. A joint investigation was conducted between the Division of Criminal Investigation (DCI) Southwest Enforcement Team (SWET), the Sublette County Sheriff's Office Narcotics Task Force (SCSO NTF), and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF).

On December 19, 2008, thirty-nine (39) year old, **Jennifer FIGUEROA** of Salt Lake City, Utah, appeared before Chief, United States District Court Judge, William F. Downes, for Sentencing. FIGUEROA entered a plea of Guilty to Count I of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine, in violation of 21 USC 841 (a)(1), (b)(1)(A) and 846.

FIGUEROA was committed to the custody United States Bureau of Prisons to be imprisoned for a term of seventy (70) months. Upon release from Imprisonment, FIGUEROA will be placed on five (5) years supervised probation, with the United States Probation Office.

The five (5) other persons involved in the Drug Conspiracy were also sentenced in 2008:

On March 20, 2008, forty (40) year old, **Lawrence Jacob HENRY Jr.** of Bondurant, Wyoming, appeared before, United States District Court Judge, Alan B. Johnson, for Sentencing. HENRY entered a plea of Guilty to Counts I and II of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine (500 grams or more) in violation of 21 U.S.C. 846 and 841 (a)(1) and (b)(1)(A), and Carrying a Firearm During and in Relation to a Drug Trafficking Crime in violation of 18 U.S.C. 924(c)(1)(A).

J. HENRY was committed to the custody United States Bureau of Prisons to be imprisoned for a term of one-hundred twenty (120) months (10 years) in relation to Count 1 and sixty (60) months (5 years) in relation to Count 2. All Counts will be served Consecutive. Upon release from Imprisonment, J. HENRY will be placed on five (5) years Supervised Release regarding Count 1 and three (3) years regarding Count 2, served concurrently.

On September 19, 2008, thirty-one (31) year old, **Shannon Michael BOZEMAN** formerly of Marbleton, Wyoming, appeared before Chief, United States District Court Judge, William F. Downes, for Sentencing. BOZEMAN entered a plea of Guilty to Count I of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine, in violation of 21 USC 841 (a)(1), (b)(1)(A) and 846.

BOZEMAN was committed to the custody United States Bureau of Prisons to be imprisoned for a term of one hundred twenty (120) months (10 years). Upon release from Imprisonment BOZEMAN, will be placed on five (5) years supervised probation, with the United Stated Probation Office.

On November 24, 2008, forty-two (42) year old, **Dwight David WALLACE**, formerly of Bondurant, Wyoming, appeared before Chief, United States District Court Judge, William F. Downes, for Sentencing. WALLACE entered a plea of Guilty to Count I of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine, in violation of 21 USC 841 (a)(1), (b)(1)(A) and 846.

WALLACE was committed to the custody United States Bureau of Prisons to be imprisoned for a term of one hundred twenty-one (121) months (10 years, 1 month). Upon release from Imprisonment WALLACE, will be placed on five (5) years supervised probation, with the United Stated Probation Office.

On November 25, 2008, fifty-one (51) year old, **Pablo SANCHEZ** of Salt Lake City, Utah, appeared before Chief, United States District Court Judge, William F. Downes, for Sentencing. SANCHEZ entered a plea of Guilty to Count I of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine, in violation of 21 USC 841 (a)(1), (b)(1)(A) and 846.

SANCHEZ was committed to the custody United States Bureau of Prisons to be imprisoned for a term of two hundred sixteen (216) months (18 years). Upon release from Imprisonment SANCHEZ, will be placed on five (5) years supervised probation, with the United Stated Probation Office.

On December 10, 2008, forty (40) year old **Marcie JOHNSON** of Salt Lake City, Utah, appeared before Chief, United States District Court Judge, William F. Downes, for Sentencing. JOHNSON entered a plea of Guilty to Count I of the Indictment, Conspiracy to Possess with Intent to Distribute, and to Distribute Methamphetamine, in violation of 21 USC 841 (a)(1), (b)(1)(A) and 846.

JOHNSON was committed to the custody United States Bureau of Prisons to be imprisoned for a term of sixty (60) months (5 years). Upon release from imprisonment, JOHNSON will be placed on five (5) years supervised probation, with the United Stated Probation Office.

Law Enforcement would like to encourage the public to continue to provide information in a timely manner when they suspect someone engaged in the use and distribution of drugs. The public is welcome to contact the Division of Criminal Investigation, DCI, SWET, and the Sublette County Sheriff's Office with information regarding illegal drugs.

The Southwest Enforcement Team is comprised of Agents from the Division of Criminal Investigation, the Sublette County Sheriff's Office, Evanston Police Department, Uinta County Sheriff's Office, Green River Police Department, Sweetwater County Sheriff's Office, and the Teton County Sheriff's Office.
