**RACER’S ACKNOWLEDGEMENT OF RISKS,
AGREEMENT TO HOLD HARMELSS,
AND LIABILITY RELEASE WAIVER**

In consideration of the services of the Pinedale Snow Explorers, their Race Committee, landowners, their officers, guards, agents, and all other persons or entities associated with those businesses (hereinafter collectively referred to as “Race Host”) I agree as follows:

Although the Race Host has taken reasonable steps to provide me with appropriate racing conditions so I can enjoy an activity for which I may not be skilled, the Race Host has informed me this activity is not without risk. Certain risks are inherent and cannot be eliminated without destroying the unique character of the activity. These inherent risks can cause loss or damage to my equipment, accidentally frighten me or reduce my enthusiasm for these activities. The Race Host believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of the risks:

WRECKING YOUR SNOWMOBILE, SOMEONE ELSE CRASHING INTO YOU, A WRECK CAUSED BY THE TERRAIN OR LACK OF VISION FROM EXCESSIVE SNOW, RAIN, DUST, OR FLYING DEBRIS, HITTING AN OBSTACLE THAT IS MARKED OR UNMARKED, PERSONAL INJURY, DEATH.

I am aware that snowmobile racing entails risks of injury or death to any participant. I understand the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks exist. My participation in this activity is purely voluntary, and I elect to participate in spite of and with full knowledge of the inherent risks. I acknowledge that the staff of the Race Host has been available to me to fully explain the nature and physical demands of the activity and the inherent risks, hazards and dangers associated with this activity.

I certify that I am fully capable of participating in the activity. I agree to assume and accept responsibility for the inherent risks identified herein and those inherent risks not specifically identified. I assume and accept full responsibility for myself – including minor children in my care, custody, or control – and for any bodily injury, death, or loss of or damage to personal property. I also assume and accept responsibility for expenses incurred as a result of participating in the activity.

I have carefully read, clearly understand, and accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representative, estate, and for all members of my family, including my minor children.

The Race Host, landowners, their officers, guards, agents, and all other persons or entities associated with those businesses will not be held responsible for any injuries or damage. I have read and understand the Racer’s Acknowledgment of Risks.
