

**Dear Voter:**

The election of a new Sheriff in Sublette County is one of the important issues facing the voters of Sublette County this year. I am glad to have this opportunity to express a few of my thoughts on this matter and to inform you of my qualifications to serve in this important office.

I have lived in Sublette County for 25 years and am a lifelong resident of Wyoming. I have a desire to serve the citizens of Sublette County in the capacity of Sheriff. Sublette County has given me a lot in those 25 years, and I'd like to return some of it.

We as citizens of Sublette County have a great desire to maintain the "quality of life" that we enjoy so very much. We have the right to feel safe in our homes and places of work and to feel that our persons and personal property are aptly protected.

- ✓ I would bring a wide variety of experience to the office of Sheriff, having been associated with law enforcement for fifteen years. I am a graduate of the Wyoming Law Enforcement Academy, and my last rating with the Peace Officers Standards and Training Commission was that of a "Professional Peace Officer." I have received extensive training from the United States Department of Justice, Drug Enforcement Administration. I have been a certified instructor for the Wyoming Peace Officers Standards and Training Commission in the area of Dangerous Drugs and Narcotics—Search and Seizure.
- ✓ I am a graduate of the National Sheriff's Institute, an intensive School of Management and Supervision, sponsored by the National Sheriff's Association at the FBI Academy in Quantico, Virginia.
- ✓ Training in all facets of law enforcement is extensive and I would be happy to discuss this with all who would be interested.
- ✓ I have an excellent capacity to organize and plan, and I have the ability to work with and around others. This has been demonstrated by my administrative work in the Lincoln Broadcasting Company, my elective term of office as Lincoln County Clerk, and in the various supervisory positions I have attained in law enforcement.
- ✓ I am dedicated, energetic, and I have the desire to do any job that is given me as well or better than it has been done before. I welcome the opportunity to prove that hard work, combined with honesty, integrity, and enthusiasm, can lead to a mutually successful relationship with the residents of the county and the Sublette County Sheriff's Office.
